Uvod

Ovim dokumentom odgovara se na najčešće postavljana pitanja u implementaciji eRačuna po standardu koji je usvojen radi potrebe potpune interoperabilnosti u koljanu eRačuna kako u Moj-eRačun mreži, tako i prema tijelima državne uprave.

Ovdje je bitno naglasiti da će ste samo potpunom kompatibilnošću eRačuna koji izlazi iz vašeg ERP-a omogućiti suprotnoj strani da taj isti eRačun učita u svoj ERP ili da će sigurno biti dostavljen prema TDU.

UBL Validacija

Kako bi provjerili da li je eRačun kojeg ste napravili po UBL standardu, XML datoteku možete učitati na online validator koji se nalazi na <https://www.moj-eracun.hr/exchange/validateUBL>

Za validaciju postoje dvije opcije:

1. UBL shema i provjera ispravnosti upisanih vrijednosti

- a. Ovdje provjeravamo minimalan set pravila popunjavanja računa u XML obliku koji je potreban da bi eRačun bio učitan u neki drugi ERP unutar Moj-eRačun mreže ili prema inozemnim zaprimateljima eRačuna.

2. Kompatibilnost za slanje prema tijelima državne uprave (TDU)

- a. Zbog nekih dodatnih polja koja se moraju ispunjavati unutar UBL-a, a koje diktira FINA, napravili smo poseban validator koji provjerava da li je XML ispunjen u skladu sa standardom kojeg se traži za TDU.

Nakon što učitate XML u validator, na ekranu će se pojaviti da je sve u redu s računom ili upozorenja i pogreške.

Upozorenja nisu greške i račun će biti ispravan za zaprimanje, ali upozoravaju kako bi neka polja trebala biti popunjena kako bi strani koja zaprima eRačun olakšali import istog. Ovo se ponajprije odnosi na referencu **na narudžbenicu i GTIN (EAN) kód artikla** koji su od velikog značaja za sve velike zaprimatelje koji sve svoje poslovne procese vode kroz ERP.

Upute za spajanje putem API-a na Moj-eRačun servis

Za spajanje na servis postoje dva API-a. Svi integratori koji su radili na V1 API-u mogu slobodno i dalje ostati na njemu.

Svi novi integratori odmah su upućeni na V2 API.

Razlika između V1 i V2 je što V2 ima puno veću propusnost i nešto bolji povrat poruke greške, što se pokazalo najbitnijim u fazi integracije

Atribut currencyID – obavezno

Svi elementi koji u sebi sadrže atribut `currencyID` moraju ga imati ispunjenog. Najčešće će to biti oznaka za Kune **HRK**. Jedan tipičan primjer gdje se ovaj atribut pojavljuje:

Implementacija poreznih shema

Radi se o najznačajnijoj izmjeni izrade računa u XML obliku, i koja je preduvjet da bi isti uopće mogao ispravno učitati u ERP na strani zaprimatelja. Za svaki tip poreza potrebno je ispuniti određeni set polja unutar pojedine linije računa **cac:InvoiceLine**, ali i na poreznoj rekapitulaciji unutar čvora **cac:TaxTotal**.
